Acden Environment Limited Partnership is seeking one (1) **Hazardous Waste Technician II** to join its **Kearl Oil Sands** operations. This position will consist of 10 on, 10 off rotation, 11.5-hour day shifts. Flight and camp accommodations will be provided through the client from designated hubs in Edmonton (Alberta) and Calgary (Alberta); however, schedules, shifts and site locations may change from time to time to meet operational requirements.

The Hazardous Waste Technician II is responsible for the safe handling, sorting and processing of hazardous waste products on site.

Duties and Responsibilities:

- Operate skid steer, forklift, and forklift mounted class truck as required
- Manifest and label hazardous waste containers
- Prepare containers for shipment in accordance with TDG standards
- Monitor inventory levels of products in the laydown and report to the supervisor as required
- Gather and empty sanitary and industrial waste and recycling receptacles/materials
- Bulk and properly segregate hazardous waste products, testing products to identify hazards
- Develop and maintain an accurate Safety Data Sheet (SDS) log
- Operate filter crusher and bulb crusher, and operate vehicles in mine environment
- Collect and exchange various hazardous waste containers around site
- Understand new tasks and follow Job Hazard Analysis (JHA), Safe Work Procedure (SWP) and Safe Job Procedure (SJP) as required by assigned tasks
- Complete and submit Near Miss Cards, Nobody Gets Hurt cards and peer to peer observations
- Maintain housekeeping and organization of laydown yard and repair and refurbish waste bins
- Understand and adhere to all Acden and client company policies and procedures
- Other duties as assigned that fulfill the demands of the role

Qualifications:

- **Valid Class 3 driver's license is required**
- Hazardous waste experience is an asset
- Post-secondary education in the sciences is an asset
- Chemical field-testing experience is an asset
- Ability to successfully complete HAZWOPER Technician course, preference will be given to candidates that have this qualification
- Forklift and skid steer certifications are an asset
- The ability to work independently or in a team environment with minimal supervision
- Clear and precise verbal and written communication skills
- Eligible to work on all Acden client sites as required by the position
- Safety driven attitude and attention to detail
- Ability to perform labour intensive duties as required

Requirements:

- **Valid Common Safety Orientation (CSO);** or OSSA BSO Certificate, or a combination of CSTS-09 and OSSA Regional certificates
- Commercial Abstract demonstrating a pattern of safe and compliant driving behavior

- Must be able to successfully complete a driver's evaluation in Fort McMurray, Alberta.
